Explanation of significant increases in the budget:

The Regular General & Emergency rates stayed the same, but the dollar amount increased due to increased Taxable Valuation. The FICA & IPERS and Other Employee Benefits increased due to being a percentage of employee pay, which has increased due to cost of living adjustments.
